<u>Updates</u>

PCH License – The 'under review with no conditions' continues for our PCH License. This is standard practice if three or more care standards are not completely met. We will continue to work on these items with documentation.

PPCO Directives – A status update was provided to PPCO in July 2019 which the PPCO office found to be satisfactory. The next report is due in January 2020.

Accreditation: - Regional accreditation has been completed with 91.4% of performance measures being met.

Communication

Temporary Signage – Temporary directional signage has been working well through the facility. We are currently working with vendors to ensure standards (such as Dementiability standards) are maintained. We hope to have signage up this fall. A wayfinding map will be located at both entrances as part of the new signage.

<u>Other</u>

Fire Doors & Snow Removal (Guest Speaker: Darren Roberts, Manager of Physical Plant Services, Maintenance) – Darren explained the process for clearing of small areas by Maintenance Staff between 0800-1615 Monday-Friday. A contract is in place with EF Moon to clear large areas on a priority basis, starting with the hospital. It typically takes two days to completely clear emergency exits and walk-ways.

Resident Handbook – The final draft was presented at the meeting with a few changes noted.

Getting to Know You Poster – This project has been successful and is nearing completion.
